Lifetime Limited Warranty on Drawer Guides and Hinges.

MasterBrand Cabinets, Inc. warrants to the original consumer purchasers for as long as they own their home that the drawers, drawer guides and hinges used in the manufacture of Decora[®] cabinetry products shall be free from defects in material and workmanship under normal use.

Five Year Limited Warranty on Cabinetry.

In addition, MasterBrand Cabinets, Inc. warrants to the original consumer purchaser for a period of five years from the original date of purchase that all other components of Decora[®] cabinetry shall be free from defects in material and workmanship under normal use.



General Warranty Guidelines.

Should Decora[®] cabinetry fail during the applicable warranty period due to defects in material or workmanship under normal use, MasterBrand Cabinets, Inc., in its discretion, will repair or provide the parts necessary to replace the defective products.

This warranty does not cover products which are misused, abused, mishandled, improperly installed, improperly stored, changed, modified, or subjected to extreme temperatures or extreme moisture levels. This warranty is not valid for products used for any purpose other than the purpose for which they were originally intended. This warranty does not cover the cost of installation, removal, subsequent damage, or transportation of the defective product, regardless of whether the work was performed by a contractor, service company or consumer.

Variations in color and grain pattern are a natural characteristic of wood. Color changes also may result from exposure to light and other elements which are a part of the aging process. These material variations and changes are not covered by this warranty. MasterBrand Cabinets, Inc. reserves the right to substitute discontinued product with the most similar product in styling, wood species and color available at the time a claim is submitted.

This warranty is the exclusive warranty of MasterBrand Cabinets, Inc. and is in lieu of all other warranties, expressed or implied. In no event shall MasterBrand Cabinets, Inc. be liable for consequential, indirect or incidental damages resulting from the installation, use or failure of its product.

Some states do not allow the exclusion or limitation of incidental or consequential damages, therefore, the above limitations or exclusions may not apply. This warranty allows specific legal rights; consumers may also have additional rights which vary from state to state.

MasterBrand Cabinets, Inc., will send the original residential purchaser a new Decora[®] dovetailed drawer box to replace any defective dovetailed drawer subject to this warranty. This is a warranty for replacement only. MasterBrand Cabinets, Inc., specifically does not cover drawers which have been exposed to abuse, misuse, or excessive loads.
